# ADRODDIAD SCAA SBAR REPORT

#### Sefyllfa / Situation

The purpose of this report is to:

- Update the Board on relevant matters undertaken as Chief Executive of Hywel Dda University Health Board (the UHB) since the previous Board meeting held on 26<sup>th</sup> November 2020; and
- Provide an overview of the current key issues, both at a local and national level, within NHS Wales.

#### Cefndir / Background

This report provides the opportunity to present items to the Board to demonstrate areas of work that are being progressed and achievements that are being made, which may not be subject to prior consideration by a Committee of the Board, or may not be directly reported to the Board through Board reports.

#### Asesiad / Assessment

#### (1) Register of Sealings

The UHB's Common Seal has been applied to legal documents and a record of the sealing of these documents has been entered into the Register kept for this purpose. The entries at **Appendix A** have been signed by the Chair and Chief Executive or the Deputy Chief Executive (in the absence of the Chief Executive) on behalf of the Board (Section 8 of the UHB's Standing Orders refers).

# (2) Consultations

The UHB receives consultation documents from a number of external organisations. It is important that the UHB considers the impact of the proposals contained within these consultations against its own strategic plans, and ensures that an appropriate corporate response is provided to highlight any issues, which could potentially impact upon the

organisation. A status report for Consultation Documents received and responded to is detailed at **Appendix B**, should any Board Member wish to contribute.

## (3)Strategic and Operational Issues

#### Transformation Steering Group

From now on, I will be providing Members with an update on the actions and recommendations from the Transformation Steering Group (TSG) in my Report.

- (i) Behavioural Insights Masterclass Warwick Business School
  - In collaboration with the Warwick Business School, the TSG undertook a Behavioural Insights Masterclass. The session focused on introducing the underlying theory powering the field of behavioural science, namely dual-process theory, explaining how our brain has two difference ways of processing information and making decisions, with the relationship between these two systems working very well most of the times but then in certain predictable scenarios also lead us to make systematic errors. The Group was then provided with a variety of practical examples to illustrate how behavioural insights can be used within the domain of healthcare to achieve positive outcomes.
  - The TSG as part on its workplan for 2021 will look to see how it can best include these principles into specific pieces of work.
- (ii) Social Model for Health and Wellbeing (SMfHW): Taking Forward Planning Objective 4.L
  - 4.L scope has been developed to enable its outcomes to be of benefit to a wide number of Planning Objectives. The name has been altered to 'Social Model of Health and Wellbeing' (from Social Model of Health, and subject to Board approval) to reflect the whole system requirements of the work, and to reference the Wellbeing of Future Generations Act and the Social Services and Well-being Act. The planning has taken into account the current operational pressures facing the UHB and its partners. The Discover phase spans the winter months and will enable work to continue to be progressed, with minimal demands of clinicians. It is proposed that the initial stage, between December 2020 and March 2021 focuses on:
    - Agreement on the scope of work with the Executive Lead
    - Establish and brief core and wider project teams for SMfHW Sign off high level Project plans
    - Complete a comprehensive stakeholder mapping exercise for SMfHW
    - Arrange to interview thought leaders from across Public life in Wales sign off the interviewee list and interview schedule and questions for the SMfHW engagement
    - Undertake a comprehensive literature review on the SMfHW based on the expert opinion of system leaders and input from the Advisory Group
    - Workshop SMfHW interview data and literature review data, progress to date info

       collate key messages into a 'Discover Report'
- (iii) Amendments to Planning Objectives: Members are asked to endorse the amendment of wording for the following objectives:
  - Planning Objective 4.J (Executive Lead Director of Public Health)
     Original:
    - By March 2022, publish a comprehensive population needs assessment covering both the health and wellbeing needs of the local population. This will need to be done in full partnership with Public Service Boards (PSBs) and the Regional Partnership Board (RPB).

- By April 2023 publish a revised Area Health and Wellbeing plan based on these assessments.
- o Implement the first year of these plans by March 2024.

## Proposed:

- Contribute to the development and publication of a comprehensive needs assessment by April 2022, which meets the requirements of the Well-being of Future Generations (Wales) Act 2015 and Social Services and Well-being (Wales) Act 2014.
- Based on these assessments, contribute to the setting of PSB and RPB objectives and the publication by April 2023 of a revised Area Plan and Wellbeing Plan for each local authority area.
- Planning Objective 4.L (Executive Lead Medical Director)
  - By March 2021, design and implement a process that continuously generates new proposals that can be developed into planning objectives aimed at constantly moving us towards a comprehensive "social model for health <u>and</u> <u>Wellbeing</u>" and cohesive and resilient communities. The process needs to involve our local population as well as a diverse set of thought and system leaders from across society
