## ADRODDIAD SCAA SBAR REPORT

### Sefyllfa / Situation

The purpose of this report is to provide an update on the outcome of the recent procurement exercise which has been undertaken to address the waiting lists for Autism Spectrum Disorder (ASD) Diagnostic Assessments for Adults and Children and Young People (CYP). This is in line with the Directorate's Planning Objective 5G, which includes the transformation of ASD services.

The outsourcing of ASD assessments will bring additional investment to services to strengthen capacity and ensure that the Health Board can comply with the newly implemented legislation on the delivery of autism services.

## Cefndir / Background

The Welsh Government (WG) targets for the percentage of CYP waiting less than 26 weeks to start a neurodevelopmental assessment is 80%, while the target for adults waiting less than 26 weeks to start an ASD assessment is also 80%. Both services are consistently in breach of these targets, with average returns of 24%.

As of September 2022, there are 426 CYP out of a total of 2,241 (19%) were waiting less than 26 weeks to start a neurodevelopment assessment for ASD, while 1,815 CYP were waiting more than 26 weeks. There are 1,243 adults waiting less than 26 weeks to start an assessment, with 963 adults waiting more than 26 weeks.

Despite staff vacancies being low, workforce capacity to meet the ongoing increasing demand is inadequate, with referral rates increasing year on year, ranging from an average of 26 referrals per month in 2016 to 87 referrals per month in March 2022 in adult services. Demand within the CYP service remains similarly high. Again, this is compounded by inadequate workforce capacity to meet the increasing demand. The Directorate is funding several fixed term additional posts to address some of these demand and capacity issues.

However due to the significant waiting lists, for Adult and CYP ASD services, the Health Board is unable to agree a realistic trajectory to meet WG targets. Issues with staff recruitment and retention has played a significant role in the lack of capacity within services to meet these targets, which has been further compounded by issues with Estates and IT infrastructure. Despite additional staff being recruited to help tackle the waiting lists, with current resources and in order to comply with NICE best practice guidance, services only have capacity to complete an average of 40 diagnostic assessments per month, which with the current average referral rate of 87 per month means that we are not in a position to agree a trajectory.

In order to implement targeted diagnostic interventions, the Directorate has undertaken an open procurement exercise to purchase services up until 31st March 2025. The contract structure of the tender has allowed for the provision of two providers to ensure maximum impact to address current waiting lists. The contract value is £1,200,000 (January 2023 – March 2025) with providers expected to undertake individual diagnostic assessments of up to 150 adults and 150 children and young people per annum.

#### Asesiad / Assessment

## **Tender Process**

A competitive open tender exercise (HDD-ITT-51433) was undertaken through the Bravo etender Wales system from 30<sup>th</sup> September 2022 to 21<sup>st</sup> October 2022. Nine suppliers viewed the tender during this period, with four responses submitted. Four providers did not respond, with one provider declining to respond due to lack of capacity to provide the service at this current time.

#### **Evaluation Process**

In order to provide a quantifiable method of evaluating the qualitative aspects of the bids, a set of weighted criteria was produced based on technical and financial information, which is set out in the table below:

The evaluation process was facilitated by the Assistant Head of Procurement, NHS Wales Shared Services Partnership alongside the Commissioning Manager, Third Sector Services and the Service Delivery Manager, Children & Adults Autism Services.

Responses were evaluated in accordance with the evaluation criteria set out in the Table 1. The finance element was scored on a pro-rata basis with the lowest total cost for the project receiving full marks of 100 points X weighting 20% = 20. The commercial and technical scores outlined in the table below were unanimously agreed by the evaluation panel.

In line with the scores set out above the evaluation panel recommends that contracts are awarded to Provider 1 & Provider 2. Both providers have confirmed that they have capacity to meet the contract requirements throughout the duration of the contract and will be allocated an equal share of the total funding available.

## **Next Steps**

Following approval to proceed with the contract award, a call off agreement will be executed to enable services to commence in January 2023.

In line with Health Board guidance service providers will adhere to NICE Guidelines, General Principles of Care and current WG legislation. Providers will offer a multi-disciplinary approach to diagnostic assessment, using flexible approaches to service delivery such as face-to-face and digital options to meet the needs of service users, which will minimise the length of time taken from referral to diagnosis.

All referrals will be screened by a clinician to determine that they meet the threshold for diagnostic assessment. Service providers will confirm the outcome of the assessment with the Health Board through a dedicated feedback/outcome session.

Services will be contract monitored by the Service Transformation & Partnerships Team in conjunction with clinical leads, Finance Business Partners and Procurement Business Partners. The Providers will produce quarterly performance monitoring reports evidencing that agreed targets, objectives and outcomes are being achieved. Service delivery capacity will be reviewed monthly to ensure that we are maximising resources to improve waiting lists.

## **Argymhelliad / Recommendation**

The Board is asked to:

APPROVE the award of contracts to Provider 1 & Provider 2 to provide services from 1<sup>st</sup> January 2023 to 31<sup>st</sup> March 2025, for onwards submission to Welsh Government for approval.
