ADRODDIAD SCAA SBAR REPORT Sefyllfa / Situation

At the March Public Board meeting, a one-year Annual Plan for 2023/24 was approved acknowledging significant risks and recognising the forecast financial outturn remains unacceptable and further work will be required during 2023/24 to improve the position and was subsequently submitted to Welsh Government on 31 March 2023. The annual plan includes a one-year financial plan and key deliverables for the next 12 months.

This paper provides the Board with an update on this Plan.

Cefndir / Background

Health Boards in Wales are required to produce a Board-approved Integrated Medium-Term Plan (IMTP) and submit to the Welsh Government for approval. A statutory requirement is that the IMTP must be financially balanced over the three-year period. Hywel Dda University Health Board (HDdUHB) was unable to do that for 2022-23, which led to the Health Board being escalated by the Welsh Government to Targeted Intervention for Planning and Finance.

As noted at previous Board meetings, whilst the ambition and aspiration for HDdUHB remains to submit an approvable IMTP, the current challenges are such that, despite our best endeavours, we are again not in a position to produce a balanced financial plan at this stage for 2023/24. Following discussion at Board, this was formally noted to Welsh Government (WG) in an accountability letter from the Chief Executive in February 2023.

In lieu of an IMTP, an annual plan was developed for 2023/24 and presented at the March 2023 Board meeting for approval. The plan considered by Board can be found at: <u>Annual Plan</u> <u>2023/24</u>. The annual plan was subsequently submitted to Welsh Government on 31 March 2023.

Asesiad / Assessment

Following submission of the plan the Health Board has received correspondence from the Director General, Health and Social Services, Welsh Government. The letter indicates that the Plan is 'not supportable or acceptable', specifically the level of financial deficit and the delivery of the Ministerial priorities. An urgent meeting was held with Welsh Government on 3 May 2023 for urgent scrutiny and discussion of our plan.

The letter from Welsh Government states a resubmission of plans is not requested. Instead we are required to submit a supplementary paper by 31 May 2023, outlining the further work undertaken and the impact this has upon plan assumptions. Ministerial templates must also be resubmitted.

At the time of writing, given the time constraints, this supplementary paper and the revised Ministerial templates are in development and, therefore, unfortunately cannot be shared with Public Board ahead of submission. A verbal update will be provided at the Public Board and once drafted, a process will be put in place to ensure that the Board can comment upon, review and approve the revised Ministerial templates ahead of submission. This will be formally presented at the July 2023 Public Board meeting.
